Petition under Section 151 of C.P.C. praying that in the circumstances stated in the affidavit filed in W.P. the High Court may be pleased to direct the 2nd respondent to reconsider the proposal of the petitioner with reference to disallowed heads of expenditure in relation to the salary paid to the non-teaching faculty as well as the estimate of salary payable in accordance with the 7th Central Pay Revision Commission w.e.f. 1.1.2016 and additional expenditure on enhanced gratuity limit with a further direction to the 1st respondent to renotify the said fee after such process pending WP No. 22595 of 2016 on the file of the High Court.
